Master's Programme: Literary Studies

These Course and Examination Regulations (henceforth OER) have been drawn up in accordance with the Higher Education and Research Act [Wet op het hoger onderwijs en wetenschappelijk onderzoek; WHW] (henceforth the Act) and the following Leiden University regulations:

- the Leiden Register of Study Programmes Framework Document;
- the Academic Calendar;
- the Regulations for Student Registration;
- the Regulations for Admission to Master's Programmes.

Pursuant to Article 7.14 of the Act, the Faculty Board regularly evaluates the Course and Examination Regulations and considers, for the purpose of monitoring and adjusting the study load, how much time it takes students to comply. In accordance with Article 9.18 of the Act, the departmental committee is assigned the task of annually assessing the implementation of the OER.

These Course and Examination Regulations consist of two sections: a faculty section that is the same for all programmes and a section that contains information that is specific to a particular programme, what is known as the programme-specific section of the Course and Examination Regulations. In the text below the relevant articles will refer to this section.

Chapter 2 Description of the Programme

Article 2.1 **Objectives of the programme**

The programme has the following objectives:

- 1. to enable students to acquire academic knowledge, understanding and skills, and train them in the use of scientific methods in the field of English, French, German and/or Italian Literary and Cultural Studies;
- 2. to enable students to develop the following academic and professional skills:
 - independent academic reasoning and conduct,
 - the ability to analyse complex problems,
 - the ability to clearly report academic results, both in writing and orally;
- 3. to prepare students for an academic career and;
- 4. to prepare students for a career outside academia.

The programme has the following specialisations:

- English Literature and Culture
- French Literature and Culture
- German Literature and Culture
- Italian Literature and Culture
- Literature in Society. Europe and Beyond

5. Learning skills

Graduates:

Article 2.5 Study load

The programme has a study load of 60 credits.

Article 2.8 Language of instruction

In compliance with the Code of Conduct regarding Language of Instruction [Gedragscode voertaal¹] the languages of instruction and examination of the programme are English and, depending on the specialisation, French, German or Italian. Students are expected to have an adequate command of the languages of instruction of the programme.

5.2.2The Faculty Board may, on request, grant admission to (one or more of the specialisations of) the programme to applicants who do not meet the requirements as specified in 5.2.1 but who can demonstrate to the satisfaction of the Faculty Board that they possess a level of knowledge, understanding and skills equal to that of holders of a degree specified in 5.2.1, possibly under further conditions.

To be considered as holding a degree equal to the one specified in 5.2.1, applicants must meet the following requirements:

• a bachelor's degree from a research university, equivalent to the level of a Dutch academic Bachelor's degree, or demonstrate to meet the requirements for such a degree, including the General Academic Skills listed in Appendix B, and

In addition, applicants must also meet the following specific requirements per specialisation:

Specialisation English Literature and Culture

- Knowledge of and insight in English Literature and Culture, comparable with the qualities acquired on completing the Bachelor's programme referred to in article 5.2.1, including:
 - knowledge of and insight in the connections with North American literature and culture;
 - knowledge of and insight in its development over the different periods (Middle Ages, Early Modern, and Modern);
 - analytical skills needed for specifically literary analysis;
 - a well-developed awareness of the relevant scholarly skills

Specialisation French Literature and Culture

- Knowledge of and insight in French Literature and Culture, comparable with the qualities acquired on completing the Bachelor's programme referred to in article 5.2.1, including:
 - knowledge of and insight in the connections with French speaking regions elsewhere in the world (so-called Francophonie);
 - knowledge of and insight in its development over the different periods (Middle Ages, Early Modern, and Modern);
 - analytical skills needed for specifically literary analysis;
 - a well-developed awareness of the relevant scholarly skills.

Specialisation German Literature and Culture

- Knowledge of and insight in German Literature and Culture, comparable with the qualities acquired on completing the Bachelor's programme referred to in article 5.2.1, including:
 - knowledge of and insight in its development over the different periods (Middle Ages, Early Modern, and Modern):
 - knowledge of and insight in cultural differences between the Netherlands and German speaking regions and elementary Dutch-German intercultural skills;
 - analytical skills needed for specifically literary analysis;
 - a well-developed awareness of the relevant scholarly skills.

Specialisation Italian Literature and Culture

- Knowledge of and insight in Italian Literature and Culture, comparable with the qualities acquired on completing the Bachelor's programme referred to in article 5.2.1, including:
 - knowledge of and insight in its position in the European literary-historical context;
 - knowledge of and insight in its development over the different periods (Middle Ages, Early Modern, and Modern);
 - analytical skills needed for specifically literary analysis;
 - a well-developed awareness of the relevant scholarly skills.

Specialisation Literature in society. Europe and Beyond.

- Knowledge of and insight in Literature and Culture, comparable with the qualities acquired on completing one of the Bachelor's programmes referred to in article 5.2.1, including:
 - basic knowledge and understanding of the history of literature and of major literary works.
 - knowledge of basic tools of literary analysis and proven ability to apply them.

- analytical skills needed for specifically literary analysis
- a well-developed awareness of the relevant scholarly skills.

5.2.3As further clarification of Article 2.8 concerning the student's command of the language of instruction, the following language requirements per specialisation apply:

Specialisation English Literature and Culture:

- English IELTS7.5/TOEFL (Internet based) 113/CPE or CAE 185;
- a minimum score of IELTS 7.0 or TOEFL 25 is required for each of the four components

The requirement to provide an English language test result applies only to students who have completed a BA English language and literature outside the Netherlands. This is at the discretion of the Admissions Board.

Specialisation French Literature and Culture

- English IELTS 7.0, TOEFL 100 (internet-based) or Cambridge English: Proficiency (CPE); and
- French at level CEFR C1, as evidenced by an appropriate test (Dalf C1 with a C1 score for each of the subtests).

Specialisation German Literature and Culture

- English IELTS 7.0, TOEFL 100 (internet-based) or Cambridge English: Proficiency (CPE); and
- German at level CEFR C1, as evidenced by an appropriate test (Goethe-Zertifikat C1)

Specialisation Italian Literature and Culture

- English IELTS 7.0, TOEFL 100 (internet-based) or Cambridge English: Proficiency (CPE); and
- Italian: CEFR C1 (listening, reading) and CEFR B2 (speaking, writing), as evidenced by an appropriate test.

Specialisation Literature in society. Europe and Beyond.

- English IELTS7.0/TOEFL (Internet based) 100/CPE or CAE 185;
- for the 'speaking' and 'writing' components, a minimum score of IELTS 7.0 of TOEFL 25 is required;

The Faculty Board may request that applicants demonstrate an adequate command at this level. 5.2.5 Not applicable.

Article 5.4 **Bridging programmes (Premasters)**

- 5.4.1 The programme has established the following premaster programmes in order to remedy deficiencies.
- a. The premaster programmes in the specialisations English, French, German and Italian literature and culture are intended for:
 - students with a relevant bachelor's degree from a research university abroad, equivalent to the level of a Dutch academic Bachelor's degree, who do not fulfill the admission requirements specified in article 5.2.2,
 - students with a Bachelor's degree from a university of applied sciences in English, French or German, equivalent to the level of a Dutch HBO bachelor's degree (lower secondary education certificate, *tweedegraads*).

b. The premaster programme in the specialization Literature in Society is intended for students with a BA in Humanities or Social Sciences from a Dutch or foreign research university, who do not fulfil the admission requirements specified in article 5.2.2.

In addition to the bridging programmes below, the Faculty Board may specify individual bridging programmes for other students who do not fully meet the entry requirements.

Students will not be admitted to the Master's programme if they have not completed the relevant bridging programme in its entirety.

Specialisation English Literature and Culture

The pre-master's programme has a study load of 60 EC and consists of first-year courses (30 credits), second-year courses (5 credits), third-year courses (10 credits), an Academic Skills course (5 credits), and the writing of a BA thesis (10 credits). Students who successfully complete this bridging programme will be admitted to the English Literature and Culture specialisation. The programme is as follows:

Specialisation Literature in Society. Europe and Beyond

This specialisation does not offer a standardised premaster programme.

However, students who have completed an academic Bachelor's programme in Humanities other than the Bachelor's programmes listed in Article 5.2.1 and who do not meet the entry requirements listed in Article 5.2.2, may be offered an individual premaster programme (5 to max. 30 credits) to remedy their deficiencies.

Students who have completed an academic Bachelor's programme in a subject other than Humanities may be offered an individual premaster programme (30 to max. 60 credits) to remedy their deficiencies.
