Master's Programme: Literary Studies

These Course and Examination Regulations (henceforth OER) have been drawn up in accordance with the Higher Education and Research Act [Wet op het hoger onderwijs en wetenschappelijk onderzoek; WHW] (henceforth the Act) and the following Leiden University regulations:

- the Leiden Register of Study Programmes Framework Document;
- the Academic Calendar;
- the Regulations for Student Registration, Tuition Fees and Examination Fees;
- the Regulations for Admission to Master's Programmes;
- the Online Proctoring Protocol Leiden University.

The model OER are laid down in Dutch and then translated into English. In the event that there are differences between the two versions, the Dutch version will prevail.

Pursuant to Article 7.14 of the Act, the Faculty Board regularly evaluates the OER and considers, for the purpose of monitoring and adjusting the study load, how much time it takes students to comply. In accordance with Article 9.18 of the Act, the departmental committee is assigned the task of annually assessing the implementation of the OER.

These Course and Examination Regulations consist of two sections:

- a faculty section that is the same for all master's programmes and
- a section that contains information that is specific to a particular programme, what is known as the programme-specific section of the Course and Examination Regulations.

In the text below the relevant articles will refer to this programme-specific section. Other articles are included in the faculty section.

# **Chapter 2** Description of the Programme

# Article 2.1 Objectives of the programme

The programme has the following objectives:

- 1. to enable students to acquire academic knowledge, understanding and skills, and train them in the use of academic methods in the field of English, French, German and/or Italian Literary and Cultural Studies;
- 2. to enable students to develop the following academic and professional skills:
  - independent academic reasoning and conduct,
  - the ability to analyse complex problems,
  - the ability to clearly report academic research results, both in writing and orally;
- 3. to prepare students for an academic career and further education, and;
- 4. to prepare students for a career outside academia.

### Article 2.2 **Specialisations**

The programme has the following specialisations:

- English Literature and Culture
- French Literature and Culture
- German Literature and Culture
- Italian Literature and Culture
- Literature in Society. Europe and Beyond

### Article 2.3 **Learning outcomes**

### General learning outcomes:

Graduates of the programme have attained the following learning outcomes, listed according to the Dublin descriptors:

1. Knowledge and understanding

Graduates:

- a. are able to demonstrate knowledge of the research methods used in the field of Literary and Cultural Studies;
- b. are able to demonstrate advanced knowledge of the field of their specialization;
- c. are able to demonstrate general knowledge of the connections between the major European literatures, and the relations of Literary Studies with other fields in the Humanities.

### 2. Applying knowledge and understanding

Graduates:

- a. have the ability to critically apply theoretical, analytical and descriptive research methods to literature and culture;

- 3. to actively participate in group discussions following

presentations, and during seminars more broadly.

Written presentation skills: graduates are able

- 1. to present clear and substantiated research results;
- 2. to provide a provisional answer to their research question:
  - a. in the form of a clear and well-structured paper or thesis;
  - b. in agreement with the appropriate disciplinary criteria;
  - c. using relevant illustration or multimedia techniques if this is relevant to the research topic;
  - d. aimed at a specific audience.

### Article 2.5 Study load

The programme has a study load of 60 credits.

### Article 2.8 Language of instruction

- 2.8.1. Subject to the Code of Conduct on the Language of Instruction and Examination<sup>1</sup> the language in which the instruction is given and in which the examinations and final examinations are held is English. For the specialisations French, German or Italian, students are expected to have an adequate command of the relevant language of instruction and examination, in accordance with the requirements stated in Article 5.2.3. As appropriate, the Faculty publishes the OER in English for English-taught programmes.
- 2.8.2. Contrary to Article 2.8.1, in individual cases, the Board of Examiners can permit the student to write the final thesis in a language different from those specified under 2.8.1, in accordance with the Guideline on Language Policy.<sup>2</sup>

# Chapter 3 Curriculum

### Article 3.1 **Compulsory components**

3.1.1 The programme includes compulsory components worth a total study load of 60 credits. These compulsory components include the set components from which students are obliged to choose. Students may take courses from the national Masterlanguage curriculum, with a total of 10 EC (5 EC per course). It is possible to take only one Masterlanguage course of 5 EC. However, this will count as an optional extra course, increasing the total number of EC to 65.

# Article 5.2 **Admission to the programme**

- 5.2.1 Holders of one of the following degrees may be admitted to the programme (Article 7.30b (1) of the Act):
  - a. A bachelor's degree from a Dutch research university (in the specialisation):

- b. To be considered as holding a degree sufficiently related to those specified under 5.2.1a, applicants must meet the following requirements:
- a bachelor's degree from a research university, equivalent to the level of a Dutch academic Bachelor's degree, including the General Academic Skills listed in Appendix B of the Faculty section of these regulations;
- In addition, applicants must meet the following specific requirements per specialisation:

### **English Literature and Culture**

- The applicant has knowledge and understanding of active (writing, speaking) and passive (reading, listening) proficiency in English at the final level of the degrees referred to in Art. 5.1.2a. See also Art. 5.2.3.2.

- The applicant has completed at least 45 EC of courses in English Literature and Culture;
- The applicant has demonstrable knowledge of and insight into North American literature and culture;
- The applicant has demonstrable knowledge of and insight into the historical development of English literature (Medieval, Early Modern, and Modern);
- The candidate has substantial literary research skills, demonstrated in a BA thesis and/or substantial research papers written as part of a BA programme.

### French Literature and Culture

- The applicant has knowledge and understanding of active (writing, speaking) and passive (reading, listening) proficiency in French at the final level of the degrees referred to in Art. 5.1.2. See also Art. 5.2.3.2.
- The applicant has completed at least 40 EC of courses in French Literature and Culture;
- The applicant has demonstrable knowledge of and insight into the connections with French-speaking regions elsewhere in the world (so-called *Francophonie*);
- The applicant has demonstrable knowledge of and insight into the historical development of French literature (Middle Ages, Early Modern, and Modern);
- The candidate has substantial literary research skills, demonstrated in a BA thesis and/or substantial research papers written as part of a BA programme.

### German Literature and Culture

- The applicant has knowledge and understanding of active (writing, speaking) and passive (reading, listening) proficiency in German at the final level of the degrees referred to in Art. 5.1.2. See also Art. 5.2.3.2.
- The applicant has completed at least 40 EC of courses in German Literature and Culture;
- The applicant has demonstrable knowledge of and insight into the historical development of German literature (Medieval, Early Modern, and Modern);
- The candidate has substantial literary research skills, demonstrated in a BA thesis and/or substantial research papers written as part of a BA programme.

### Italian Literature and Culture

- The applicant has knowledge and understanding of active (writing, speaking) and passive (reading, listening) proficiency in Italian at the final level of the degrees referred to in Art. 5.1.2. See also Art. 5.2.3.2.
- The applicant has completed at least 25 EC of courses in Italian Literature and Culture;
- The applicant has demonstrable knowledge of and insight into the historical development of Italian literature (Medieval, Early Modern, and Modern);
- The candidate has substantial literary research skills, demonstrated in a BA thesis and/or substantial research papers written as part of a BA programme.

### Literature in Society. Europe and Beyond

- The applicant has completed at least 30 EC of courses in literary studies.
- The applicant has demonstrable working knowledge and understanding of the history of literature and of major literary works.
- The candidate has substantial literary research skills, demonstrated in a BA thesis and/or substantial research papers written as part of a BA programme.

Applicants with a bachelor's degree in International Studies are considered as having fulfilled all entry requirements for the specialisation *Literature in Society. Europe and Beyond*, provided they have obtained at least 30 EC in literary studies.

Applicants with a bachelor's degree in American Studies, European Studies, Arts and Culture Studies or Liberal Arts and Sciences with a focus on the Humanities are considered as having fulfilled all

entry requirements for the specialisation *Literature in Society. Europe and Beyond*, provided that they have acquired at least 30 EC in literary studies.

- c. a bachelor's degree and additionally having passed the prescribed pre-master's/bridging programme pursuant to article 5.4.1. Students may overrun the allotted time for the prescribed pre-masters/bridging programme by one semester (in case of a pre-master's/bridging programme of 30 EC or less) or one study year (in case of a pre-master's/bridging programme of more than 30 EC).
- 5.2.2 Any person who fails to meet the degree requirements or prescribed pre-master's requirement referred to in 5.2.1 may submit a request to the Board of Admissions. The Board of Admissions assesses whether the applicant may be granted admission to the programme.

To this end, the Board of Admissions assesses whether the applicant possesses sufficient knowledge, understanding and skills at the same level as a bachelor's degree or related bachelor's degree as referred to in 5.2.1, (a) and (b) or whether they meet these conditions after additional requirements have been met. The Board of Admissions assesses, where relevant, whether the applicant meets the qualitative selection requirements referred to in 5.2.4.

### Admission process

Applicants as referred to in Article 5.2.1.b and Article 5.2.2 are requested to provide the Board of Admissions with:

- copies of diploma(s) and transcript(s);
- proof of language proficiency (if applicable, see 5.2.3);
- curriculum vitae (resumé);
- a completed 'Questionnaire Master Application' demonstrating that the candidate 1) has gained knowledge, understanding and skills in the field (of the specialisation) of the MA programme and 2) has acquired general academic skills as listed in Appendix B of the Faculty section of these regulations.

The admission process may include an interview with the Board of Admissions, should this be necessary to clarify whether the applicant has the same level of knowledge, understanding and skills as holders of a degree specified in 5.2.1.a.

### 5.2.3 Language requirements

5.2.3.1 As further clarification of Article 2.8 concerning command of the language of instruction, students wishing to be admitted to an English-taught master's programme must have one of the following diplomas, or must meet the criteria of:

- an <u>International Baccalaureate</u> diploma from a programme taught in English (or an IB diploma with English A);
- a diploma of secondary or higher education completed in Australia, Canada (with the exception of French-taught programmes in Canada), Ireland, Malta, New Zealand, Singapore, the United Kingdom, the United States or South-Africa;
- a diploma of an English-taught university degree programme completed at a Dutch research university;
- a Dutch pre-university education (VWO) diploma.

5.2.3.2 If a student who wishes to be admitted does not meet the requirements in 5.2.3.1, at least one of the following English language requirements for the specialisations for this master's programme can be set.

The following language requirements per specialisation apply:

### **English Literature and Culture:**

• English IELTS 7.5, where each separate constituent score must be at least 7.0, TOEFL (Internet based) 113, where each separate constituent score must be at least 25<sup>3</sup>;

The requirement to provide an English language test result applies to all students who have completed a Bachelor's programme other than the Bachelor's programme referred to in article 5.2.1a and b. This is at the discretion of the Board of Admissions.

#### French Literature and Culture

- English IELTS 6.5, where each separate constituent score must be at least 6.0, TOEFL 90 (internet-based) where each separate constituent score must be at least 20<sup>3</sup>, and
- French at level CEFR C1, as evidenced by an appropriate test (DALF C1 with a C1 score for each of the subtests).

### German Literature and Culture

- English IELTS 6.5, where each separate constituent score must be at least 6.0, TOEFL 90 (internet-based), where each separate constituent score must be at least 20<sup>3</sup>, and
- German at level CEFR C1, as evidenced by an appropriate test (Goethe-Zertifikat C1)

#### Italian Literature and Culture

- English IELTS 6.5, where each separate constituent score must be at least be 6.0, TOEFL 90 (internet-based), where each separate constituent score must be at least 20<sup>3</sup> and
- Italian: CEFR C1 (listening, reading) and CEFR B2 (speaking, writing), as evidenced by an appropriate test.

### Literature in Society. Europe and Beyond.

• English IELTS 6.5, where each separate constituent score must be at least 6.0, TOEFL 90 (internet-based), where each separate constituent score must be at least 20<sup>3</sup>.

At the time when the student applies for the programme, the test must have been taken no more than two calendar years previously.

### Article 5.4 **Pre-master's Programmes**

- 5.4.1 The programme has developed pre-master's programmes (for the target groups listed below) aimed at addressing deficiencies in a prospective student's knowledge and skillset. Pre-master's programmes/bridging programmes must be completed successfully within the prescribed period, as specified in Article 5.2.1c.
- a. The pre-master programmes in the specialisations English, French, German and Italian literature and culture are intended for:
  - students with a relevant bachelor's degree from a research university abroad, equivalent to the level of a Dutch academic Bachelor's degree who do not fulfill the admission requirements specified in article 5.2.2.
  - students with a Bachelor's degree in English, French or German from a university of applied sciences, equivalent to the level of a Dutch hbo bachelor's degree (i.e. lower secondary education teaching qualification, or *tweedegraads*).
- b. The pre-master programme in the Literature in Society specialisation is intended for students who have a BA degree in Humanities or Social Sciences from a Dutch or foreign research university, but who do not fulfil the admission requirements specified in article 5.2.1b.

For other categories of students who do not meet the admission requirements as specified in article 5.2.1b, the Faculty Board may draw up a pre-master's programme tailored to the prospective student's individual background, to be completed before admission into the MA programme.

Students will not be admitted to the Master's programme if they have not completed the relevant premaster programme in its entirety.

### **English Literature and Culture**

The pre-master programme has a study load of 60 EC and consists of first-year courses (20 EC), second-year courses (20 EC), third-year courses (5 EC), and an Academic Skills course (5 EC), and the writing of a pre-master final assignment (10 EC). Students who successfully complete this pre-master programme will be admitted to the English Literature and Culture specialisation. The programme is as follows:
